(915) 872-8531 * All City Permits/ Certificate of Appropriateness must be displayed on the jobsite. * Staff may require additional information if it is deemed necessary to complete the application. * The applicant affected by any denial of the HLC regarding a Certificate of Appropriateness may appeal the decision to the City Council for final determination. All requests shall be filed in writing to the HPO within 10 days of the HLC's decision. * If the Certificate of Appropriateness is approved, a building permit must be obtained within 1 (one) year from the date of approval, otherwise, the Certificate of Appropriateness is null and void and must be reconsidered. * Submission/Approval of Certificate of Appropriateness, does not constitute approval of a building permit. Building permits shall be submitted separately. This form must be presented at the time of a request for a building permit. * If the property owner does not appear personally before the commission, a letter or signature of authorization must be presented to the Historic Preservation Officer or the case will not be heard. CERTIFICATION I certify that the information contained in this application for a COA is correct and complete to the best of my knowledge, and that I am now or will be fully prepared to present the application to the HLC at its public hearing. I understand that the HLC may consider my application regardless of whether I or my agent or representative is present at the public hearing.
