50 Cubic yards (32.2 m) or less	no charge

101 to 1,000 cubic yards	\$75.00
1001 to 10,000 cubic yards	\$125.00
10,001 to 100,000 cubic yards - \$125.00 for first 10,000 & \$50.00 for each additional 10,000 yards or fraction thereof.	
100,001 to 200,000 cubic yards - \$575.00 for first 100,000 & \$50.00 for each additional 10,000 cubic yards or fraction thereof.	
200,001 cubic yards or more \$1,025.00 for the first 200,000 & \$50.00 for each additional 10,000 cubic yards or fraction thereof.	
<i>Other fees:</i> Additional plan review charges will be required for changes, additions or revisions to approved plans, minimum charge of half-hour or the total hourly cost to the jurisdiction, whichever is greatest. This cost shall include supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved.

<i>Other fees:</i> All inspections and re-inspections during and outside normal business hours will be assessed at \$60.00 per hour. Minimum charge will be one half hour.	

Condition of Permit

1. Job to be completed within five working days.
2. *All inspections are done between the hours of 7:30 am – 3:00 pm. Inspections required before or after these hours require separate fee (\$60.00 per inspection) and must be scheduled at least 24 hours in advance. Emergency inspections will be handled on a case-by-case basis.*
3. Applicant shall notify the City at least FOUR hours **before** backfilling and 24 hours **after** backfilling is completed.
4. If the City is to backfill, applicant shall notify the City immediately.
5. Applicant shall notify the City when HMAC hot mix work is completed.
6. The Public Works Department oversees all excavations within the city.
7. The Public Works Department has authority to stop construction if rules and regulations are not followed.
8. If rules and regulations are not followed, the contact person with the Utility Company will be notified and then the Utility Company must complete work within two days. If not, the City will take responsibility to complete the work and charge the Utility Company market value price.
