Horizon, Socorro, Texas, for Contractor(s) and any members of the <u>public that wish to witness the bid opening</u>, <u>on Tuesday</u>, November 15<sup>th</sup>, 2022 at 3:30 p.m., unless posted otherwise, for furnishing the City with the replacement of the Rio Vista Rd. and Bovee Rd., Bridge Project Solicitation No. <u>22-14</u>.

Bidders may ask the Design Engineer questions about the project from October 24th, 2022 thru November 2nd, 2022 at 5:00 p.m. All questions will be received by email and shall be sent to Jose L. Reyes at <u>Jose.Reyes@DECorp.com</u>. Responses will be provided to all prospective bidders at email address provided by <u>November 9th</u>, 2022.

Bidders on this Project must be prequalified by TXDOT.

A Non-Mandatory Pre-Bid Conference Meeting will be held on **November 1st**, **2022 at 1:00 p.m.**, **at City of Socorro**, **860 N**. **Rio Vista Rd**.
