BORDER SECURITY

Legislation seeks to increase penalties for certain criminal conduct related to smuggling persons or operating stash houses

1st CALLED SPECIAL SESSION

- Both the House and Senate passed their respective property tax relief plans
- Relief is achieved through school district tax rate compression
- Additional provisions include a \$100,000 homestead exemption by a school district
- The House ruled that SB1 is not germane to the governor's call and did not refer the bill to a committee
- The House adjourned sine die after passing property tax relief plans and border security legislation
- The Senate passed the same bill
- Multiple sessions will likely be called based on Abbott's recent comments to media

WHEREAS, in adopting Resolution 727, the City of Socorro intended to exercise all lawful powers, including to indicate the City's acknowledgement of the percentage of Housing Tax Credits per total households within the relevant area; and

WHEREAS, Tropicana Building II, LLC has notified the City of Socorro that the Texas Department of Housing and Community Affairs has requested that the City of Socorro make clear, by its adoption of Resolution 727, that the City expressly acknowledge that the census tract in which Nevarez Palms II is to be located contains more than 20% Housing Tax Credit Units per total households.

It is hereby RESOLVED, that the City of Socorro, acting through its governing body, hereby amends Resolution 727, effective as the date of its adoption, to: (i) acknowledge that the census tract in which Nevarez Palms II is to be located contains more than 20% Housing Tax Credit Units per total households; and (ii) confirm that the City of Socorro reaffirms its support for Tropicana Building II, LLC's application to the Texas Department of Housing and Community Affairs for 2023 Competitive 9% Housing Tax Credits for Nevarez Palms II; and

FURTHER RESOLVED that for and on behalf of the governing body, Mayor Ivy Avalos is hereby authorized, empowered, and directed to certify these resolutions to the Texas Department of Housing and Community Affairs.
