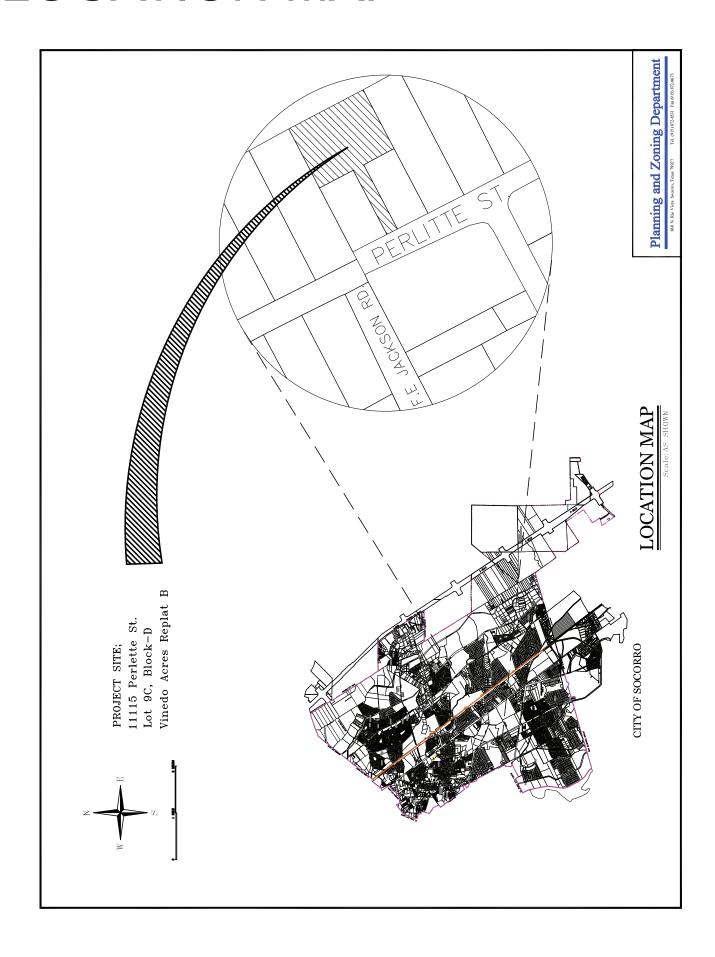
# CH. 46 - ZONING ARTICLE IV. DISTRICT REGULATIONS DIVISION 3. R-1 - SINGLE FAMILY RESIDENTIAL

#### Sec. 46-237. - Conditional uses (requires permit).

Conditional uses in this zone shall include:

- (1)Churches, hospitals, schools, and religious and philanthropic institutions provided, however, that such uses shall be located on sites of sufficient size to meet off-street parking requirements of this article and to provide setback from all property as required of this article and to provide setback for all property lines a distance of at least one foot for each foot of building height or yard setback minimums as set out in section 46-238, whichever is greater.
- (2)Real estate sales office in connection with a specific development, allowable only as a renewable condition for six months at a time.
- (3)Recreational facility (non-profit) such as a community center, swimming pool, or tennis club.
- (4)Child care homes.
- (5)Parking of commercial vehicles provided that:
  - a.) The property on which the vehicle is parked consists of a lots of one-half an acre or more in size.
  - b.) No mechanical work shall be allowed at such property.
  - c.) Vehicles must be parked on a concrete slab. The location of the slab cannot interfere with onsite ponding areas.
  - d.) Vehicles shall not idle for more than 15 minutes at any time.
  - e.) Only one vehicle may be allowed per lot. The vehicle must stay onsite and at no time, shall it be parked on the public street or right-of-way.
  - f.) At no time, shall tractor trailers be allowed to be stored on a residential lot.

WHEREAS, the City of Socorro, Texas, USA and Macharaviaya, Malaga, Spain have very significant connections on the Camino Real de Tierra Adentro and,

WHEREAS, both cities seek to enrich cultural understanding, create adult and student exchange opportunities and broaden cooperation to encourage goodwill between the cities, and;

WHEREAS, the City of Socorro, Texas, USA and Macharaviaya, Malaga, Spain support the preservation and promotion of Hispanic culture, heritage, and history and the promotion of mutual understanding, expansion of official and non-governmental exchanges, and friendship through the promotion of peace, stability and prosperity in the world at large, and;

WHEREAS, in order to develop a Sister City Relationship with cooperation between the city of City of Socorro, Texas, USA and Macharaviaya, Malaga, Spain, all cities agree to support a Sister City Relationship on the following terms:

- 1. To promote common prosperity and development, all cities will organize, on the basis of equality, mutual benefit and goodwill, cultural exchanges, and other information sharing that may include art, business, and commerce, culture, government administration, health and sports interests, history, science, technology and other information sharing.
- 2. Citizens, civic and business groups of each city are recognized as ambassadors of goodwill to organize cultural exchanges that may include the above topics.
- 3. Each city shall organize cultural exchanges, to the extent possible.
- 4. Each city agrees to promote, protect, and preserve Hispanic history, culture, and heritage in the respective cities and regions.
- 5. Cultural exchange visit details and activities shall be cooperatively agreed upon by organizing citizens, civic and business groups. Activities shall be provided with the objective to deepen cultural awareness and friendship between citizens, business leaders and government officials.

- 6. The leaders and top-level department administrators of all cities shall maintain and facilitate open channels of communication to expedite consultation, exchange, and cooperation on questions of issues and common concern.
- 7. All cities agree that all elements of the Sister City Relationship are to remain noncontroversial and will maintain the historically controversial political issues play no part in these Sister City Relationships.
- 8. The effective term for this Memorandum of Understanding shall be for a period of two years, following the date of execution of this Memorandum. Prior to the expiration of this Memorandum of Understanding, the City of Socorro, Texas, USA and Macharaviaya, Malaga, Spain, may evaluate the progress of the relationship, as well as recommend whether the relationship shall continue and either party may terminate this Memorandum with thirty (30) days written notice to the other side without cause.

- 10. This Memorandum of Understanding represents the entire agreement between the cities. It may not be changed or modified without a resolution signed by the leaders of all cities.

WHEREAS, A delegation from Socorro is traveling to Macharaviaya, Spain, for the Annual Speaking Tour promoting the Camino Real de Tierra Afuera which passes through Central Texas, and Hispanic Heritage Month throughout the world. The delegation includes a representative from the Cities of Socorro and San Elizario that will deliver Sister City agreements from both cities and will direct a signing ceremony via live streaming with the Mayors of the three cities on hand; and

WHEREAS, located in the province of Malaga, Macharaviaya was officially founded in 1572, though the local church was built in 1505 and recognized by King Fernando in 1510; the town was home to the famous poet Salvador Rueda as well as the influential Galvez family; and

WHEREAS, with a current population of approximately 400 residents, Macharaviaya is charming town with cobblestone streets and whitewashed, stone-wall houses; its focal point is Iglesia de San Jacinto, built on the site of the original parish church; and

WHEREAS, the city hosts and annual Fourth of July celebration to recognize its hometown hero, Bernardo de Galvez, and his contributions to U.S. history, an honorary citizen of the United States, Mr. Galvez supported the American Revolutionary War effort by providing supplies and intelligence to American forces and defeating the British in five military campaigns on U.S. soil; Bernardo de Galvez, was instrumental in the relocating the decommissioned Spanish Presidio in Guajoquilla, New Spain, to la Hacienda de Los Tiburcios in San Elizario. This presidio was specifically constructed to protect and supply the Socorro, Ysleta, and Senecu Missions: as part of the July festivities, Macharaviava hosts a parade and a reenactment of the capture of Fort George in Pensacola, which was a crucial victory in the Revolutionary War; and

WHEREAS, as the birthplace of Bernardo de Galvez, Macharaviaya played a noteworthy role in the campaign for American independence, and its citizens may take great pride in the town's rich history;

#### **SUMMARY**
