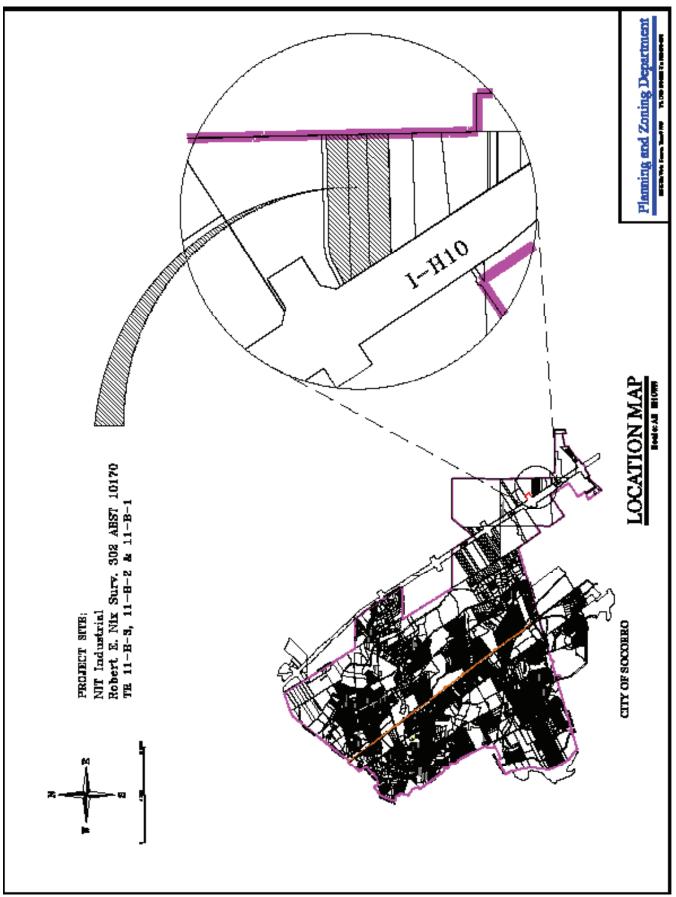

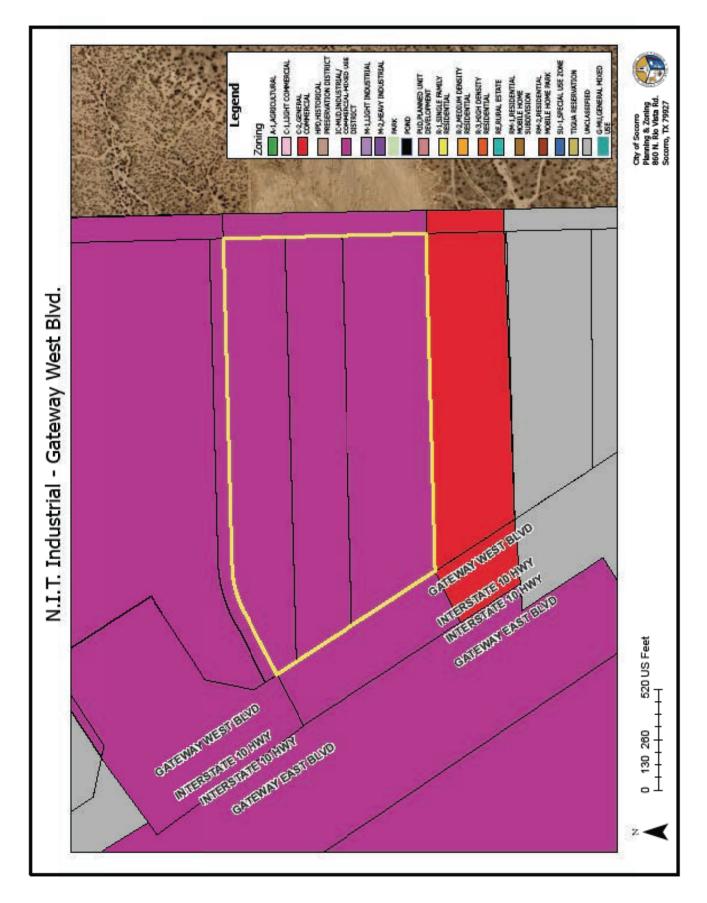

ZONING MAP



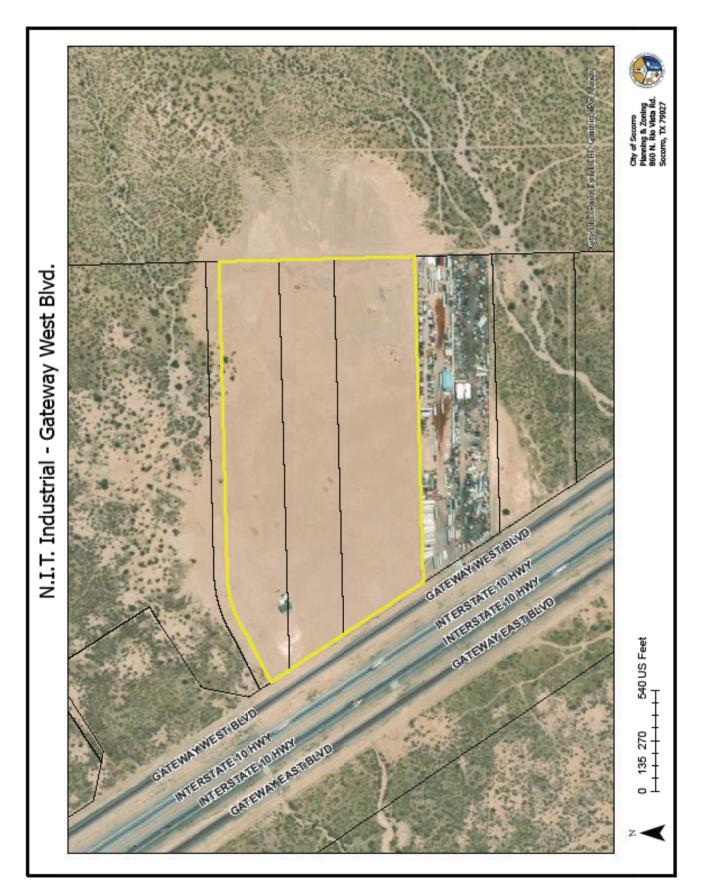

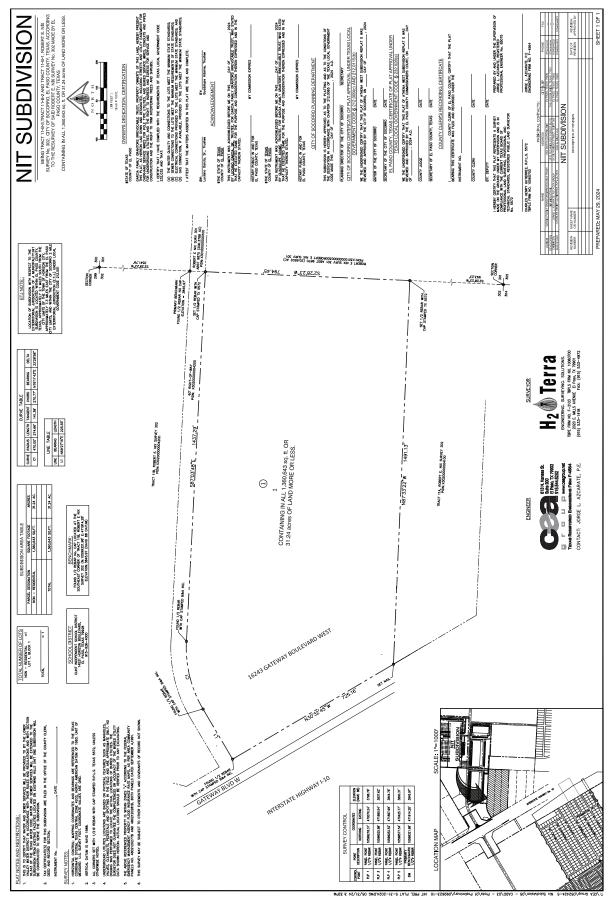

Northbound movements in both the AM and PM Peaks have a LOS D with existing traffic and forecasted traffic, the level of service remains the same. It must be noted during the traffic counting and analysis Loop 375 and Americas Ave were under construction and the low LOS may be due to some of the resulting approaches to failure, or failure. As with the SB movements, other NB movements are favorable and, thus, it is the NB movements that are causing the intersection to remain with an LOS D.

Inglewood Dr/North Loop Dr

Existing NB approaches to the intersection are approaching LOS D. The queuing traffic is not very long, but the single lane approach to the intersection may be the contributing factor as the intersection only has approximately 60 feet of two-lane capabilities to allow right turn traffic to que alongside left turn traffic. Future forecasts keep the LOS at a D for the NB movement.

Inglewood Dr/Nevarez Rd, Inglewood Dr/Alameda Ave, and five (5) proposed access points All of these intersections and access points have a LOS A throughout the analysis.

Nevarez Rd/Alameda Ave

This intersection is included within the existing and forecasted analysis as it is one of the three intersections that provides an inlet/outlet to and from the development area. Nevarez Rd has an existing SB movement that is at LOS F in the AM Peak and LOS E in the PM Peak. This is due to the queuing for the left turn movement into Alameda Ave. The traffic on Alameda Ave is heavy flowing in both directions at both peak hours and it is inevitable the wait for a safe left turn from Nevarez Rd would exist and only get worse LOS with natural and Build forecasted traffic numbers.

RECOMMENDATIONS

Americas Ave SB and NB/North Loop Dr

Both sides of the intersections going SB and NB need to be optimized to assist in creating favorable LOS in all movements and in the intersection as a whole. It is recommended the intersection be analyzed in its own analysis which is beyond the scope of this study.

Inglewood Dr/North Loop Dr

To improve the NB left and right turn movement and queuing, it is recommended further analysis be done to analyze potential strategies to improve the NB queuing approach. Additionally, the intersection should be analyzed to study the option of optimizing the signal to provide more cycle timing and improved phase timing.

Nevarez Rd/Alameda Ave

Nevarez Rd would need to be analyzed in a separate analysis to see what feasible strategies could be utilized at this intersection to improve the SB left turn LOS. The roadway and the intersection is not favorable for heavy freight truck traffic and it is not anticipated freight truck traffic from the development will be utilizing this intersection.

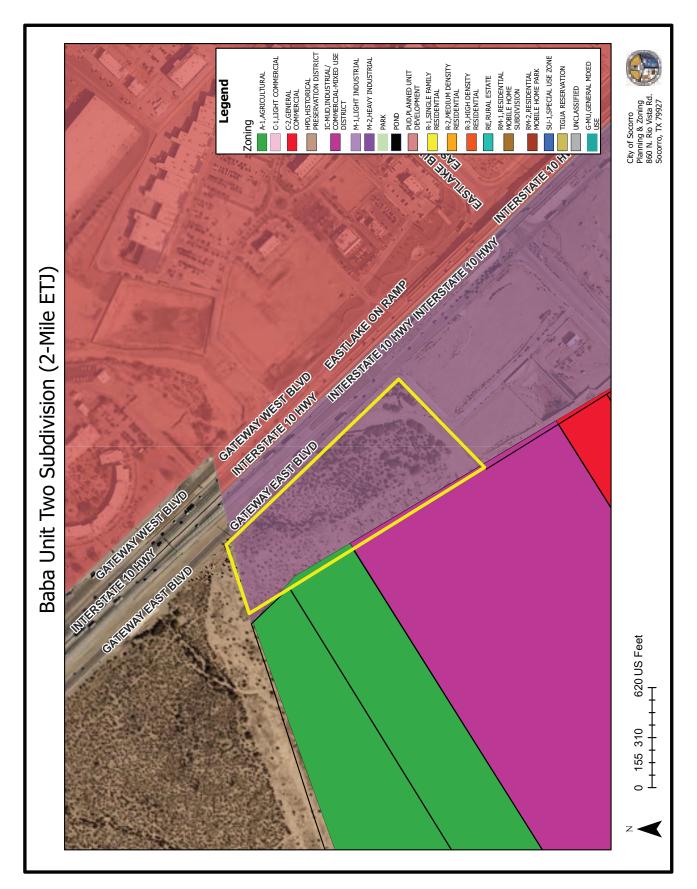

ZONING MAP



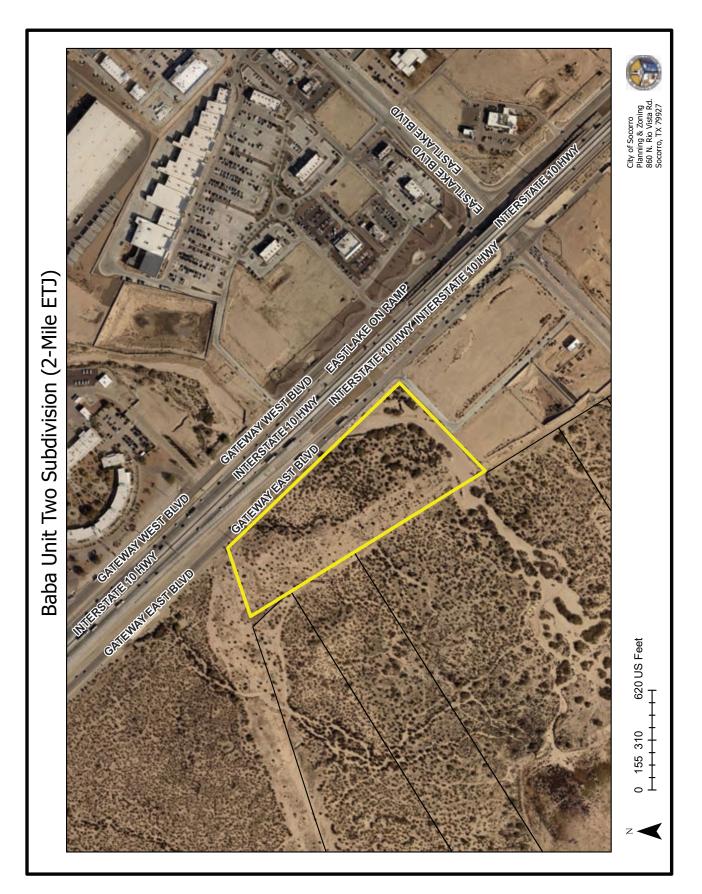

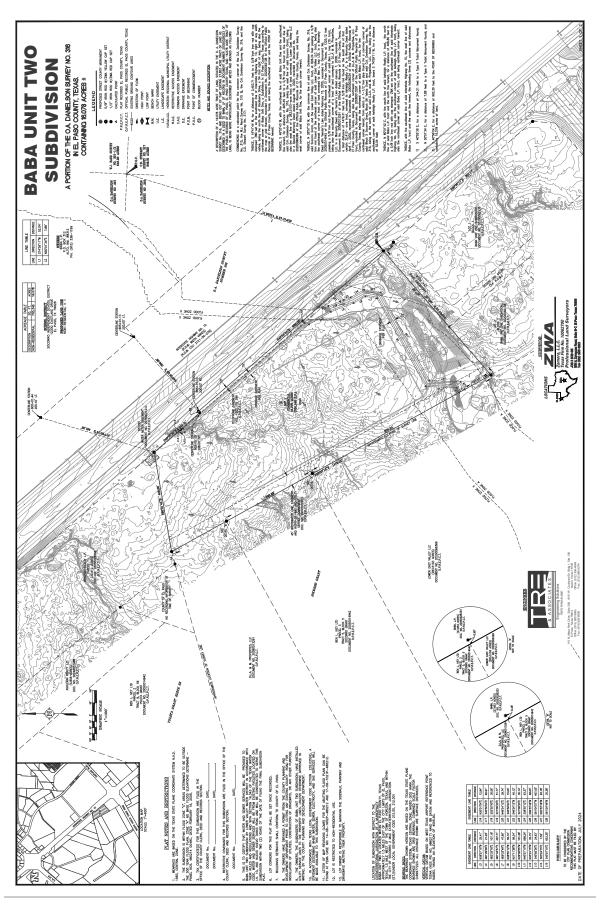

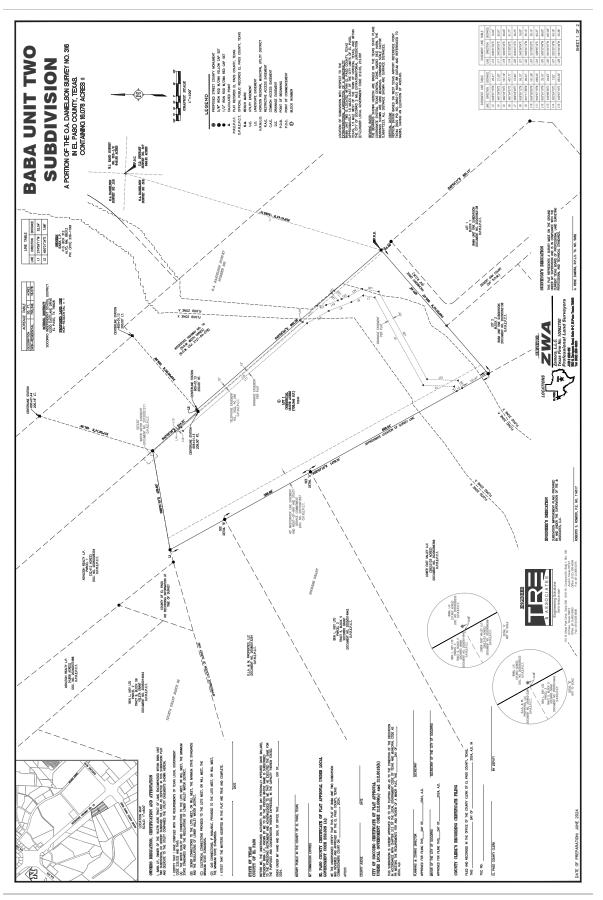

SUBJECT: *Discussion and action* to approve Resolution 799 for a Mutiple User Agreement between Texas Department of Transportation and City of Socorro Police Department.

SUMMARY:

The City of Socorro Police Department seeks approval for a resolution/ordinance authorizing the City's participation in a multiple use agreement with the state. This agreement will permit the construction, maintenance, and operation of seven public fixed mounted license plate readers (LPRs) on the highway right of way. These LPRs will enhance law enforcement capabilities, support investigations of serious crimes, and contribute to overall community security.

BACKGROUND:

The City of Socorro, under the leadership of Chief of Police Robert C. Rojas, is committed to leveraging technology to enhance public safety and efficiency. License plate readers have become a vital tool in modern policing, providing real-time data to identify and apprehend criminal suspects, track stolen vehicles, and ensure community safety. The proposed locations for the LPRs have been strategically selected based on traffic volume and crime data analysis.

STATEMENT OF THE ISSUE

The City of Socorro seeks authorization to enter into a multiple use agreement with the state for the installation and operation of license plate readers (LPRs) on highway rights of way. These LPRs are essential for enhancing law enforcement capabilities by quickly identifying stolen vehicles, supporting criminal investigations with valuable data, and efficiently locating wanted or missing persons.

WHEREAS, the State has indicated its willingness to approve the establishment of such facilities and other uses conditioned that the <u>Name for Contract</u> will enter into agreements with the State for the purpose of determining the respective responsibilities of the <u>Name for Contract</u> and the State with reference thereto, and conditioned that such uses are in the public interest and will not damage the highway facilities, impair safety, impede maintenance or in any way restrict the operation of the highway facility, all as determined from engineering and traffic investigations conducted by the State.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the parties hereto to be by them respectively kept and performed as hereinafter set forth, it is agreed as follows:

1. DESIGN AND CONSTRUCTION

Name for Contract will prepare or provide for the construction plans for the facility, and will provide for the construction work as required by said plans at no cost to the State. Said plans shall include the design of the access control, necessary horizontal and vertical clearances for highway structures, adequate landscape treatment, adequate detail to ensure compliance with applicable structural design standards, sufficient traffic control provisions, and general layout. They shall also delineate and define the construction responsibilities of both parties hereto. Completed plans will be submitted to State for review and approval and when approved shall be attached to the agreement and made a part thereof in all respects. Construction shall not commence until plans have been approved by the State. Any future revisions or additions shall be made after prior written approval of the State. Any sidewalks, curb ramps and other pedestrian elements to be constructed, either on site or off site, by the Name for Contract shall be in accordance with the requirements of Title II of the Americans With Disabilities Act (ADA) and with the Texas Accessibility Standards (TAS). Elements constructed by the

Name for Contract and found not to comply with ADA or TAS shall be corrected at the entire expense of the Name for Contract.

2. INSPECTION

Ingress and egress shall be allowed at all times to such facility for Federal Highway Administration personnel and State Forces and equipment when highway maintenance operations are necessary, and for inspection purposes; and upon request, all parking or other activities for periods required for such operations will be prohibited.

3. PARKING REGULATIONS

Parking regulations shall be established limiting parking to single unit motor vehicles of size and capacity no greater than prescribed for $1^{1/2}$ ton trucks, such vehicles to conform in size and use to governing laws. Parking shall be permitted only in marked spaces.

Parking shall be prohibited when a security threat, as determined by TxDOT, exists.

4. PROHIBITION/SIGNS

Regulations shall be established prohibiting the parking of vehicles transporting flammable or explosive loads and prohibiting use of the area in any manner for peddling, advertising or other purposes not in keeping with the objective of a public facility. The erection of signs other than those required for proper use of the area will be prohibited. All signs shall be approved by the State prior to the actual erection.

5. **RESPONSIBILITIES**

Timely maintenance, repair and operation of the facility shall be entirely the responsibility of the <u>Name for Contract</u>. Such responsibility shall not be transferred, assigned or conveyed to a third party without the advanced written approval of the State. These responsibilities expressly include the timely maintenance and repair of any portion of the facility necessary to comply with the Americans with Disabilities Act. Further, such responsibility shall include picking up trash, mowing and otherwise keeping the facility in a clean and sanitary condition, and surveillance by police patrol to eliminate the possible creation of a nuisance or hazard to the public. Hazardous or unreasonably objectionable smoke, fumes, vapor or odors shall not be permitted to rise above the grade line of the highway, nor shall the facility subject the highway to hazardous or unreasonably objectionable dripping, droppings or discharge of any kind, including rain or snow.

If the State determines that Name for Contract has failed to comply with these responsibilities, it will perform the necessary work and charge Name for Contract the actual cost of the work.

6. FEES

Any fees levied for use of the facilities in the area shall be nominal and no more than are sufficient to defray the cost of construction, maintenance and operations thereof, and shall be subject to State approval.

A. Retention Period. The <u>Name for Contract</u> shall maintain all books, documents, papers, accounting records and other evidence pertaining to fees collected and costs (hereinafter called the Records). The <u>Name for Contract</u> shall make the records available during the term of the Agreement and for four years from the date the Agreement is terminated, until completion of all audits, or until pending litigation has been completely and fully resolved, whichever occurs last.

B. Audit Report. If fees are collected by the Name for Contract for the use of the facility under this agreement, the Name for Contract will provide the State an annual audit report detailing the fees collected for the use of the facility and the costs associated with constructing, maintaining, and operating the facility within the same period. If the report shows more fees collected than expenses for the construction, operation, or maintenance of the facility the

Name for Contract must provide a multiple year plan detailing how the additional revenue will be used for construction, operation, or maintenance of the facility.

C. Availability. The State or any of its duly authorized representatives, the Federal Highway Administration, the United States Department of Transportation, Office of Inspector General, and the Comptroller General shall have access to the <u>Name for Contract</u>'s records that are directly pertinent to this Agreement for the purpose of making audits and examinations.

7. TERMINATION UPON NOTICE

This provision is expressly made subject to the rights herein granted to both parties to terminate this agreement upon notice, and upon the exercise of any such right by either party, all obligations herein to make improvements to said facility shall immediately cease and terminate and

8. MODIFICATION/TERMINATION OF AGREEMENT

If in the sole judgment of the State it is found at any future time that traffic conditions have so changed that the existence or use of the facility is impeding maintenance, damaging the highway facility, impairing safety or that the facility is not being properly operated, that it constitutes a nuisance, is abandoned, or if for any other reason it is the State's judgment that such facility is not in the public interest, this agreement under which the facility was constructed may be: (1) modified if corrective measures acceptable to both parties can be applied to eliminate the objectionable features of the facility; or (2) terminated and the use of the area as proposed herein discontinued.

9. PROHIBITION OF STORAGE OF FLAMMABLE MATERIALS

All structures located or constructed within the area covered by the agreement shall be fire resistant. The storage of flammable, explosive or hazardous materials is prohibited. Operations deemed to be a potential fire hazard shall be subject to regulation by the State.

10. RESTORATION OF AREA

The Name for Contract shall provide written notification to the State that such facility will be discontinued for the purpose defined herein. The Name for Contract shall, within thirty (30) days from the date of said notification, clear the area of all facilities that were its construction responsibility under this agreement and restore the area to a condition satisfactory to the State.

11. PREVIOUS AGREEMENTS

It is understood that this agreement in no way modifies or supersedes the terms and provisions of any existing agreements between the parties hereto.

12. INDEMNIFICATION

THE <u>Name for Contract</u> WILL INDEMNIFY THE STATE AGAINST ANY AND ALL DAMAGES AND CLAIMS FOR DAMAGES, INCLUDING THOSE RESULTING FROM INJURY OR DEATH OF PERSONS OR FOR LOSS OF OR DAMAGE TO PROPERTY, ARISING OUT OF, INCIDENT TO OR IN ANY MANNER CONNECTED WITH THE CONSTRUCTION, OPERATION OR MAINTENANCE OF THE FACILITY, WHICH INDEMNIFICATION SHALL EXTEND TO AND INCLUDE ANY AND ALL COURT COSTS, ATTORNEY'S FEES AND EXPENSES RELATED TO OR CONNECTED WITH ANY CLAIMS OR SUITS FOR DAMAGES AND SHALL, IF REQUESTED IN WRITING BY THE STATE TO DO SO, ASSIST THE STATE OR RELIEVE THE STATE FROM DEFENDING ANY SUCH SUITS BROUGHT AGAINST IT. THE INDEMNIFICATION OF THE STATE SHALL EXTEND FOR A PERIOD OF TWO (2) YEARS BEYOND THE DATE OF TERMINATION OF THIS AGREEMENT.

DURING EACH YEAR WHILE THERE IS ANY LIABILITY BY REASON OF THE AGREEMENT CONTAINED IN THIS SUBSECTION OF THIS RESOLUTION, INCLUDING THE CALENDAR YEAR <u>20XX</u>, THE <u>City Name</u> (CITY) SHALL COMPUTE AND ASCERTAIN THE RATE AND AMOUNT OF AD VALOREM TAX, BASED ON THE LATEST APPROVED TAX ROLLS OF SAID ENTITY, WITH FULL ALLOWANCES BEING MADE FOR TAX DELINQUENCIES AND COSTS OF TAX COLLECTION, WHICH WILL BE SUFFICIENT TO RAISE AND PRODUCE THE MONEY REQUIRED TO PAY ANY SUMS WHICH MAY BE OR BECOME DUE DURING ANY SUCH YEAR, IN NO INSTANCE TO BE LESS THAN TWO (2%) PER CENT OF SUCH OBLIGATION, TOGETHER WITH INTEREST THEREON, BECAUSE OF THE OBLIGATION HEREIN ASSUMED.

SAID RATE AND AMOUNT OF AD VALOREM TAX IS HEREBY ORDERED TO BE LEVIED AND IS HEREBY LEVIED AGAINST ALL TAXABLE PROPERTY IN SAID ENTITY FOR EACH YEAR WHILE ANY LIABILITY EXISTS BY REASON OF THE OBLIGATION UNDERTAKEN BY THIS SUBSECTION OF THIS RESOLUTION, AND SAID AD VALOREM TAX SHALL BE ASSESSED AND COLLECTED EACH SUCH YEAR UNTIL ALL OF THE OBLIGATIONS HEREIN INCURRED SHALL HAVE BEEN DISCHARGED AND ALL LIABILITY HEREUNDER DISCHARGED.

No party to this agreement intends to waive, relinquish, limit or condition its general governmental immunity from liability in any way.

Each party agrees and acknowledges that it is not an agent, servant, or employee of the other party and that under this provision each party is responsible only for its own acts and for those of its agents, servants, independent contractors or employees. Such responsibility includes, but is not limited to any claims or amounts arising or recovered under the "Workers Compensation Law," the Texas Tort Claims Act, Chapter 101, Texas Civil Practice and Remedies Code; or any other applicable laws or regulations, all as time to time may be amended.

Nothing in this agreement shall be construed as creating any liability in favor of any third party against the State and the <u>Name for Contract</u>. Additionally, this agreement shall not ever be construed as relieving any third party from any liability against the State. Furthermore, the

Name for Contract shall become fully subrogated to the State's rights of recovery and shall be entitled to maintain any action over and against any third party who may be liable for damages. The State agrees to execute and deliver instruments and papers and to otherwise do that which is necessary to secure such rights.

13. INSURANCE

The <u>Name for Contract</u>, shall provide necessary safeguards to protect the public on State maintained highways including adequate insurance for payment of any damages which might result during the construction, maintenance, repair and operation of the facility. <u>Name for Contract</u> shall include TxDOT as an additional insured by endorsement in <u>Name for Contract</u> 's commercial general liability insurance policy. Prior to beginning work on the State's right of way, the <u>Name for Contract</u> 's construction contractor shall submit to the State a completed insurance form (TxDOT Form No. 1560) or appropriate certificate of self-insurance and shall maintain the required coverage during the construction of the facility.

14. USE OF RIGHT OF WAY

It is understood that the State by execution of this agreement does not impair or relinquish the State's right to use such land for highway purposes when it is required for the construction or re-construction of the traffic facility for which it was acquired, nor shall use of the land under such agreement ever be construed as abandonment by the State of such land acquired for highway purposes, and the State does not purport to grant any interest in the land described herein but merely consents to such use to the extent its authority and title permits.

15. ADDITIONAL CONSENT REQUIRED

The State asserts only that it has sufficient title for highway purposes. The <u>Name for Contract</u> shall be responsible for obtaining such additional consent, permits or agreement as may be necessary due to this agreement. This includes, but is not limited to, appropriate permits and clearances for environmental, ADA and public utilities.

16. FHWA ADDITIONAL REQUIREMENTS

If the Facility is located on the Federal-Aid Highway System, "ATTACHMENT A", which states additional requirements as set forth in the Federal Highway Administration's Title 23, Code of Federal Regulations, § 710, shall be attached to and become a part of this agreement.

17. CIVIL RIGHTS ASSURANCES

The <u>Name for Contract</u>, for itself, its personal representatives, successors and interests and assigns, as part of the consideration hereof, does hereby covenant and agree as a covenant running with the land that: (1) no persons, on the grounds of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination in the use of said facility; (2) that in the construction of any improvements on, over or under such land and the furnishing of services thereon, no person on the ground of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, be denied the benefits of, or be otherwise of on, over or under such land and the furnishing of services thereon, no person on the ground of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, denied the benefits of, or otherwise be subjected to discrimination; (3) that the

Name for Contract shall use the premises in compliance with all other requirements imposed by or pursuant to Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-Assisted programs of the Department of Transportation - Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations may be amended.

That if in the event of any breach of the above non-discrimination covenants, the State shall have the right to terminate the agreement and reenter and repossess said land and the facilities thereon, and hold the same as if said agreement had never been made or issued.

18. AMENDMENTS

Any changes in the time frame, character or responsibilities of the parties hereto shall be enacted by a written amendment executed by both parties hereto.

19. LEGAL CONSTRUCTION

In case one or more of the provisions contained in this agreement shall for any reason be held invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any provision hereof and this agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained in this agreement.

20. AUDIT

The State may conduct an audit or investigation of any aspect of this agreement. The Name for Contract must provide the State with access to any information the State considers relevant to the investigation or audit. The audit can include, but is not limited to, any contract for construction or maintenance of any facility or structure authorized by this agreement or any contract to provide a service to the <u>Name for Contract</u> if that service is authorized by this agreement.

21. AUTHORITY OF STATE AUDITOR

The state auditor may conduct an audit or investigation of any entity receiving funds from the state directly under the contract or indirectly through a subcontract under the contract. Acceptance of funds directly under the contract or indirectly through a subcontract under this contract acts as acceptance of the authority of the state auditor, under the direction of the legislative audit committee, to conduct an audit or investigation in connection with those funds. An entity that is the subject of an audit or investigation must provide the state auditor with access to any information the state auditor considers relevant to the investigation or audit.

22. NOTICES

All notices required under this agreement shall be mailed or hand delivered to the following respective addresses:

23. TIMELY PAYMENT

When required by any provision of this agreement requires a payment to be made to the State, the other party hereto shall within thirty (30) days from receipt of the State's written notification pay the State for the full cost of repairing any damages to the highway facility which may result from the other party's construction, maintenance, repair or operation of the facility.

24. WARRANTS

The signatories to this agreement warrant that each has the authority to enter into this agreement on behalf of the party represented.

Any sidewalks, curb ramps and other pedestrian elements to be constructed, either on site or off site, by the Name for Contract shall be in accordance with the requirements of Title II of the Americans With Disabilities Act (ADA) and with the Texas Accessibility Standards (TAS). Elements constructed by the

Name for Contract and found not to comply with ADA or TAS shall be corrected at the entire expense of the Name for Contract.

2. INSPECTION

Ingress and egress shall be allowed at all times to such facility for Federal Highway Administration personnel and State Forces and equipment when highway maintenance operations are necessary, and for inspection purposes; and upon request, all parking or other activities for periods required for such operations will be prohibited.

3. PARKING REGULATIONS

Parking regulations shall be established limiting parking to single unit motor vehicles of size and capacity no greater than prescribed for $1^{1/2}$ ton trucks, such vehicles to conform in size and use to governing laws. Parking shall be permitted only in marked spaces.

Parking shall be prohibited when a security threat, as determined by TxDOT, exists.

4. PROHIBITION/SIGNS

Regulations shall be established prohibiting the parking of vehicles transporting flammable or explosive loads and prohibiting use of the area in any manner for peddling, advertising or other purposes not in keeping with the objective of a public facility. The erection of signs other than those required for proper use of the area will be prohibited. All signs shall be approved by the State prior to the actual erection.

5. **RESPONSIBILITIES**

Timely maintenance, repair and operation of the facility shall be entirely the responsibility of the <u>Name for Contract</u>. Such responsibility shall not be transferred, assigned or conveyed to a third party without the advanced written approval of the State. These responsibilities expressly include the timely maintenance and repair of any portion of the facility necessary to comply with the Americans with Disabilities Act. Further, such responsibility shall include picking up trash, mowing and otherwise keeping the facility in a clean and sanitary condition, and surveillance by police patrol to eliminate the possible creation of a nuisance or hazard to the public. Hazardous or unreasonably objectionable smoke, fumes, vapor or odors shall not be permitted to rise above the grade line of the highway, nor shall the facility subject the highway to hazardous or unreasonably objectionable dripping, droppings or discharge of any kind, including rain or snow.

If the State determines that Name for Contract has failed to comply with these responsibilities, it will perform the necessary work and charge Name for Contract the actual cost of the work.

6. FEES

Any fees levied for use of the facilities in the area shall be nominal and no more than are sufficient to defray the cost of construction, maintenance and operations thereof, and shall be subject to State approval.

A. Retention Period. The <u>Name for Contract</u> shall maintain all books, documents, papers, accounting records and other evidence pertaining to fees collected and costs (hereinafter called the Records). The <u>Name for Contract</u> shall make the records available during the term of the Agreement and for four years from the date the Agreement is terminated, until completion of all audits, or until pending litigation has been completely and fully resolved, whichever occurs last.

B. Audit Report. If fees are collected by the Name for Contract for the use of the facility under this agreement, the Name for Contract will provide the State an annual audit report detailing the fees collected for the use of the facility and the costs associated with constructing, maintaining, and operating the facility within the same period. If the report shows more fees collected than expenses for the construction, operation, or maintenance of the facility the

Name for Contract must provide a multiple year plan detailing how the additional revenue will be used for construction, operation, or maintenance of the facility.

C. Availability. The State or any of its duly authorized representatives, the Federal Highway Administration, the United States Department of Transportation, Office of Inspector General, and the Comptroller General shall have access to the <u>Name for Contract</u>'s records that are directly pertinent to this Agreement for the purpose of making audits and examinations.

7. TERMINATION UPON NOTICE

This provision is expressly made subject to the rights herein granted to both parties to terminate this agreement upon notice, and upon the exercise of any such right by either party, all obligations herein to make improvements to said facility shall immediately cease and terminate and

8. MODIFICATION/TERMINATION OF AGREEMENT

If in the sole judgment of the State it is found at any future time that traffic conditions have so changed that the existence or use of the facility is impeding maintenance, damaging the highway facility, impairing safety or that the facility is not being properly operated, that it constitutes a nuisance, is abandoned, or if for any other reason it is the State's judgment that such facility is not in the public interest, this agreement under which the facility was constructed may be: (1) modified if corrective measures acceptable to both parties can be applied to eliminate the objectionable features of the facility; or (2) terminated and the use of the area as proposed herein discontinued.

9. PROHIBITION OF STORAGE OF FLAMMABLE MATERIALS

All structures located or constructed within the area covered by the agreement shall be fire resistant. The storage of flammable, explosive or hazardous materials is prohibited. Operations deemed to be a potential fire hazard shall be subject to regulation by the State.

10. RESTORATION OF AREA

The Name for Contract shall provide written notification to the State that such facility will be discontinued for the purpose defined herein. The Name for Contract shall, within thirty (30) days from the date of said notification, clear the area of all facilities that were its construction responsibility under this agreement and restore the area to a condition satisfactory to the State.

11. PREVIOUS AGREEMENTS

It is understood that this agreement in no way modifies or supersedes the terms and provisions of any existing agreements between the parties hereto.

12. INDEMNIFICATION

THE <u>Name for Contract</u> WILL INDEMNIFY THE STATE AGAINST ANY AND ALL DAMAGES AND CLAIMS FOR DAMAGES, INCLUDING THOSE RESULTING FROM INJURY OR DEATH OF PERSONS OR FOR LOSS OF OR DAMAGE TO PROPERTY, ARISING OUT OF, INCIDENT TO OR IN ANY MANNER CONNECTED WITH THE CONSTRUCTION, OPERATION OR MAINTENANCE OF THE FACILITY, WHICH INDEMNIFICATION SHALL EXTEND TO AND INCLUDE ANY AND ALL COURT COSTS, ATTORNEY'S FEES AND EXPENSES RELATED TO OR CONNECTED WITH ANY CLAIMS OR SUITS FOR DAMAGES AND SHALL, IF REQUESTED IN WRITING BY THE STATE TO DO SO, ASSIST THE STATE OR RELIEVE THE STATE FROM DEFENDING ANY SUCH SUITS BROUGHT AGAINST IT. THE INDEMNIFICATION OF THE STATE SHALL EXTEND FOR A PERIOD OF TWO (2) YEARS BEYOND THE DATE OF TERMINATION OF THIS AGREEMENT.

DURING EACH YEAR WHILE THERE IS ANY LIABILITY BY REASON OF THE AGREEMENT CONTAINED IN THIS SUBSECTION OF THIS RESOLUTION, INCLUDING THE CALENDAR YEAR <u>20XX</u>, THE <u>City Name</u> (CITY) SHALL COMPUTE AND ASCERTAIN THE RATE AND AMOUNT OF AD VALOREM TAX, BASED ON THE LATEST APPROVED TAX ROLLS OF SAID ENTITY, WITH FULL ALLOWANCES BEING MADE FOR TAX DELINQUENCIES AND COSTS OF TAX COLLECTION, WHICH WILL BE SUFFICIENT TO RAISE AND PRODUCE THE MONEY REQUIRED TO PAY ANY SUMS WHICH MAY BE OR BECOME DUE DURING ANY SUCH YEAR, IN NO INSTANCE TO BE LESS THAN TWO (2%) PER CENT OF SUCH OBLIGATION, TOGETHER WITH INTEREST THEREON, BECAUSE OF THE OBLIGATION HEREIN ASSUMED.

SAID RATE AND AMOUNT OF AD VALOREM TAX IS HEREBY ORDERED TO BE LEVIED AND IS HEREBY LEVIED AGAINST ALL TAXABLE PROPERTY IN SAID ENTITY FOR EACH YEAR WHILE ANY LIABILITY EXISTS BY REASON OF THE OBLIGATION UNDERTAKEN BY THIS SUBSECTION OF THIS RESOLUTION, AND SAID AD VALOREM TAX SHALL BE ASSESSED AND COLLECTED EACH SUCH YEAR UNTIL ALL OF THE OBLIGATIONS HEREIN INCURRED SHALL HAVE BEEN DISCHARGED AND ALL LIABILITY HEREUNDER DISCHARGED.

No party to this agreement intends to waive, relinquish, limit or condition its general governmental immunity from liability in any way.

Each party agrees and acknowledges that it is not an agent, servant, or employee of the other party and that under this provision each party is responsible only for its own acts and for those of its agents, servants, independent contractors or employees. Such responsibility includes, but is not limited to any claims or amounts arising or recovered under the "Workers Compensation Law," the Texas Tort Claims Act, Chapter 101, Texas Civil Practice and Remedies Code; or any other applicable laws or regulations, all as time to time may be amended.

Nothing in this agreement shall be construed as creating any liability in favor of any third party against the State and the <u>Name for Contract</u>. Additionally, this agreement shall not ever be construed as relieving any third party from any liability against the State. Furthermore, the

Name for Contract shall become fully subrogated to the State's rights of recovery and shall be entitled to maintain any action over and against any third party who may be liable for damages. The State agrees to execute and deliver instruments and papers and to otherwise do that which is necessary to secure such rights.

13. INSURANCE

The <u>Name for Contract</u>, shall provide necessary safeguards to protect the public on State maintained highways including adequate insurance for payment of any damages which might result during the construction, maintenance, repair and operation of the facility. <u>Name for Contract</u> shall include TxDOT as an additional insured by endorsement in <u>Name for Contract</u> 's commercial general liability insurance policy. Prior to beginning work on the State's right of way, the <u>Name for Contract</u> 's construction contractor shall submit to the State a completed insurance form (TxDOT Form No. 1560) or appropriate certificate of self-insurance and shall maintain the required coverage during the construction of the facility.

14. USE OF RIGHT OF WAY

It is understood that the State by execution of this agreement does not impair or relinquish the State's right to use such land for highway purposes when it is required for the construction or re-construction of the traffic facility for which it was acquired, nor shall use of the land under such agreement ever be construed as abandonment by the State of such land acquired for highway purposes, and the State does not purport to grant any interest in the land described herein but merely consents to such use to the extent its authority and title permits.

15. ADDITIONAL CONSENT REQUIRED

The State asserts only that it has sufficient title for highway purposes. The <u>Name for Contract</u> shall be responsible for obtaining such additional consent, permits or agreement as may be necessary due to this agreement. This includes, but is not limited to, appropriate permits and clearances for environmental, ADA and public utilities.

16. FHWA ADDITIONAL REQUIREMENTS

If the Facility is located on the Federal-Aid Highway System, "ATTACHMENT A", which states additional requirements as set forth in the Federal Highway Administration's Title 23, Code of Federal Regulations, § 710, shall be attached to and become a part of this agreement.

17. CIVIL RIGHTS ASSURANCES

The <u>Name for Contract</u>, for itself, its personal representatives, successors and interests and assigns, as part of the consideration hereof, does hereby covenant and agree as a covenant running with the land that: (1) no persons, on the grounds of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination in the use of said facility; (2) that in the construction of any improvements on, over or under such land and the furnishing of services thereon, no person on the ground of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, be denied the benefits of, or be otherwise of on, over or under such land and the furnishing of services thereon, no person on the ground of race, color, sex, age, national origin, religion or disabling condition, shall be excluded from participation in, denied the benefits of, or otherwise be subjected to discrimination; (3) that the

Name for Contract shall use the premises in compliance with all other requirements imposed by or pursuant to Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-Assisted programs of the Department of Transportation - Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations may be amended.

That if in the event of any breach of the above non-discrimination covenants, the State shall have the right to terminate the agreement and reenter and repossess said land and the facilities thereon, and hold the same as if said agreement had never been made or issued.

18. AMENDMENTS

Any changes in the time frame, character or responsibilities of the parties hereto shall be enacted by a written amendment executed by both parties hereto.

19. LEGAL CONSTRUCTION

In case one or more of the provisions contained in this agreement shall for any reason be held invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any provision hereof and this agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained in this agreement.

20. AUDIT

The State may conduct an audit or investigation of any aspect of this agreement. The Name for Contract must provide the State with access to any information the State considers relevant to the investigation or audit. The audit can include, but is not limited to, any contract for construction or maintenance of any facility or structure authorized by this agreement or any contract to provide a service to the <u>Name for Contract</u> if that service is authorized by this agreement.

21. AUTHORITY OF STATE AUDITOR

The state auditor may conduct an audit or investigation of any entity receiving funds from the state directly under the contract or indirectly through a subcontract under the contract. Acceptance of funds directly under the contract or indirectly through a subcontract under this contract acts as acceptance of the authority of the state auditor, under the direction of the legislative audit committee, to conduct an audit or investigation in connection with those funds. An entity that is the subject of an audit or investigation must provide the state auditor with access to any information the state auditor considers relevant to the investigation or audit.

22. NOTICES

All notices required under this agreement shall be mailed or hand delivered to the following respective addresses:

When required by any provision of this agreement requires a payment to be made to the State, the other party hereto shall within thirty (30) days from receipt of the State's written notification pay the State for the full cost of repairing any damages to the highway facility which may result from the other party's construction, maintenance, repair or operation of the facility.

24. WARRANTS

The signatories to this agreement warrant that each has the authority to enter into this agreement on behalf of the party represented.

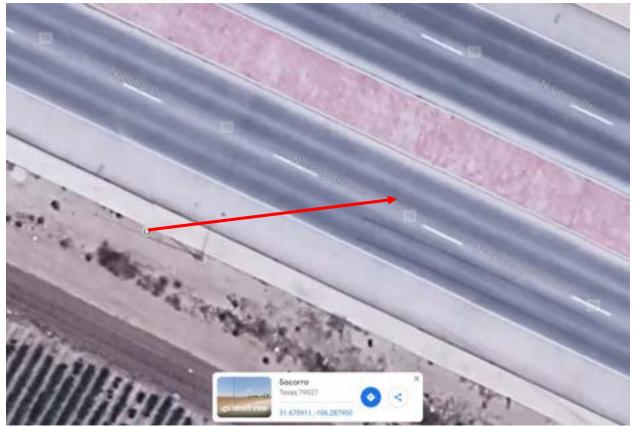

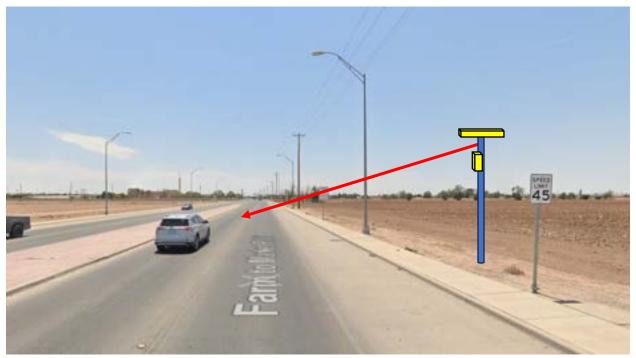


Figure 1: Facing South on FM76 (June 2021) Cross Street is North Moon Road – El Paso County, TX – 5ft radius around the white eight-inch circle.

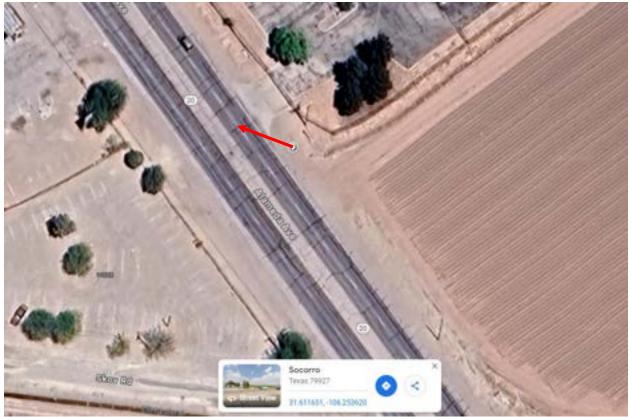

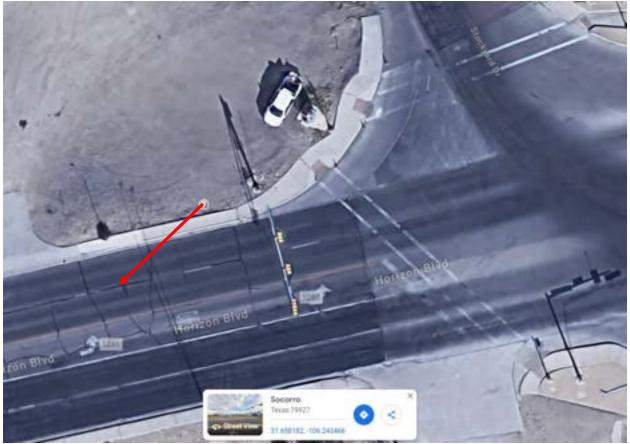

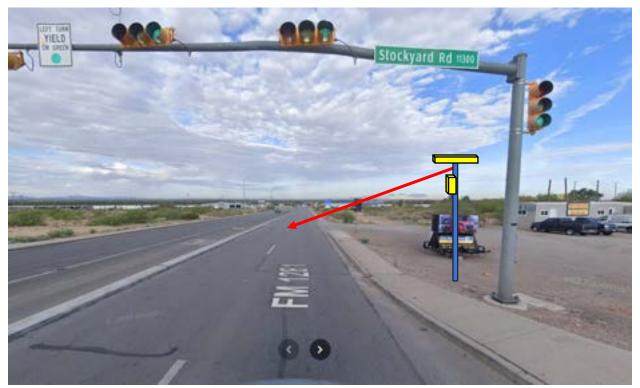


Figure 1: Facing West on Horizon Boulevard (July 2022) Cross Street is Stockyard Drive – El Paso County, TX – 5ft radius around the white eight-inch circle.

SIGNAL DEVELOPMENT AGREEMENT

COUNTY OF EL PASO

THIS SIGNAL DEVELOPMENT AGREEMENT (the "Agreement') is by and between the City of Socorro, Texas, a Texas municipality (the "City"), and El Paso Jamas, Ltd., a Texas limited partnership (the "Owner"), collectively referred to as "Parties", is entered into as of ______, 2024, ("Effective Date").

Recitals

Whereas, the City and the Owner entered into a Settlement Agreement dated December 17, 2015 for the development of Nuevo Hueco Tanks Road;

Whereas, the Owner owns land within the limits of the City now known as Lots 1 and 2, Block 2, Hueco Junction Unit 1 and Lot 3, Block 1 and Lots 1-4, Block 2 Valle Nuevo Commercial Center #1;

Whereas, the City and the Owner desire to construct a new Traffic Signal at the intersection of Nuevo Hueco Tanks and Hueco Junction ("Traffic Signal");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. <u>Construction of the Traffic Signal:</u>

- a. The Parties agree that the Owner, shall design and construct, the Traffic Signal in substantial conformity to the existing signal at the intersection of Nuevo Hueco Tanks Blvd and Socorro Logistics Lane attached hereto as Exhibit "A".
- b. Construction and Payment of the Traffic Signal: The Parties agree that the Traffic Signal has become necessary, as commercial businesses are under development along Nuevo Hueco Tanks Blvd. Parties recognize that Article 212, Subchapter C, of the Texas Local Government Code provides a means for a private developer to incorporate certain City owned improvements into its development process through a contract with the City without a competitive bidding process. The parties agree that this document constitutes a Developer Participation Contract for the purpose of Article 212, in that the Parties agree that Owner may construct the Traffic Signal under the terms and conditions provided herein.
- c. Owner's Right/Time to Construct the Traffic Signal: Owner has the right to construct the Traffic Signal.
 - This agreement shall serve as the Owner's notice of intent to construct the Traffic Signal.

- The Traffic Signal design and specifications must meet standards and requirements for a public traffic signal in the City. The Owner has engaged GRV Integrated Engineering Solutions (GRV) for the design of the Traffic Signal as its design engineering consultant.
- The City shall make a timely review of the design as submitted by GRV and shall provide the Owner with its approval of the design. Said approval shall not be unreasonably withheld.
- Owner shall have one year after the City's formal approval of the design to complete the construction of the Traffic Signal.
- d. Payment and Reimbursement for Traffic Signal: When the Owner constructs the Traffic Signal, it will do so it is own initial expense; however, the City will reimburse the Owner thirty percent (30%) of the actual cost of design and construction of the Traffic Signal, which 30% shall in no event exceed \$150,000. City and Owner agree that the Owner shall include in its costs a ten percent (10%) fee for administrative, supervision and oversight.
- e. City Maintenance, Ownership, and Control of the Traffic Signal: The City will accept and retain full and complete ownership, control of, and maintenance responsibility for, the Traffic Signal after construction is complete. Owner agrees to deliver to the City clear and unencumbered title, via Bill of Sale, to all public improvements contemplated by this Agreement which are constructed by Owner subject to any matters of record affecting the property. The design and construction of the Traffic Signal is subject to and controlled by City ordinance(s) or code(s) or both.
- 5. Representations and Warranties

a. City's Representations and Warranties. The City hereby represents and warrants to Owner the City has the legal authority, right, and power under current law to execute, deliver, and perform the terms and obligations of this Agreement, and all of the foregoing have been or will be duly and validly authorized and approved by all necessary City proceedings, findings and/or actions. Accordingly, this Agreement constitutes a legal and binding obligation of the City, is enforceable in accordance with its terms and provisions, and does not require the consent of any other governmental authority. The City further agrees to waive its sovereign immunity, to the maximum extent permitted by law, if at all, with respect to Owner's right to enforce this Agreement.

b. Owners' Representations and Warranties. Owner hereby represents and warrants to the City that Developer has the full legal authority, right, and power under current law to execute, deliver and perform the terms and obligations of this Agreement, and all the foregoing have been or will be duly and validly authorized and approved by actions necessary to bind Owner. Accordingly, this Agreement constitutes a legal and binding obligation of Owner, is enforceable in accordance with its terms and provisions, and does not require the consent of any other governmental authority or entity.

6. <u>Miscellaneous Provisions</u>.

a. Amendment and Waiver. This Agreement and any provision thereof may be amended or waived only if such amendment or waiver is in writing and approved by Owner and the City. No course of dealing on the part of Owner or the City, nor any failure or delay by Owner or the City with respect to exercising any right, power, or privilege pursuant to this Agreement, shall operate as a waiver thereof, except as otherwise provided herein.

b. Severability. Should any of the provisions of this Agreement be held unenforceable, vague or ambiguous in any respect, such unenforceability, vagueness or ambiguity shall not affect any other provisions of this Agreement, and all provisions, covenants, agreements and portions of this Agreement are declared by the Parties to be severable.

c. Governing Law, Venue. This Agreement shall be governed by laws of the State of Texas. Any dispute regarding this Agreement shall be brought in El Paso County, Texas.

d. Headings. The headings throughout this Agreement are for convenience and reference only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.

e. Notices. Any notice sent under this agreement shall be written and mailed by certified mail, return receipt requested, or sent by personal or hand delivery with written confirmation of acceptance to the following:

i. Construction. The parties acknowledge that the parties and their counsel have reviewed and revised this Agreement, and that the normal rule of construction to the effect that any ambiguities are to be resolved against the drafting party shall not be employed in the interpretation of this Agreement or any amendments or exhibits hereto.

j. Force Majeure. If any action at law or in equity, including an action for declaratory relief, is brought to enforce or interpret the provisions or this Agreement, the prevailing party shall be entitled to recover reasonable attorney's fees from the other party, which fees may be set by the Court in the trial of such action or may be enforced in a separate action brought for that purpose, and which fees shall be in addition to any other relief which may be awarded.

p. No Admissions. It is understood and agreed that this Agreement is the compromise of an existing dispute and is not intended to be construed as an admission of liability on the part of any party hereto.

q. Acknowledgement. Each party hereto acknowledges that he has read and understands the effect of this Agreement and executes this Agreement of his own free will and accord for the purposes and considerations set forth.

r. Other Obligations. Each party shall do all other acts, or deliver any other instruments or documents required or helpful to be done or delivered, in order to consummate this transaction.

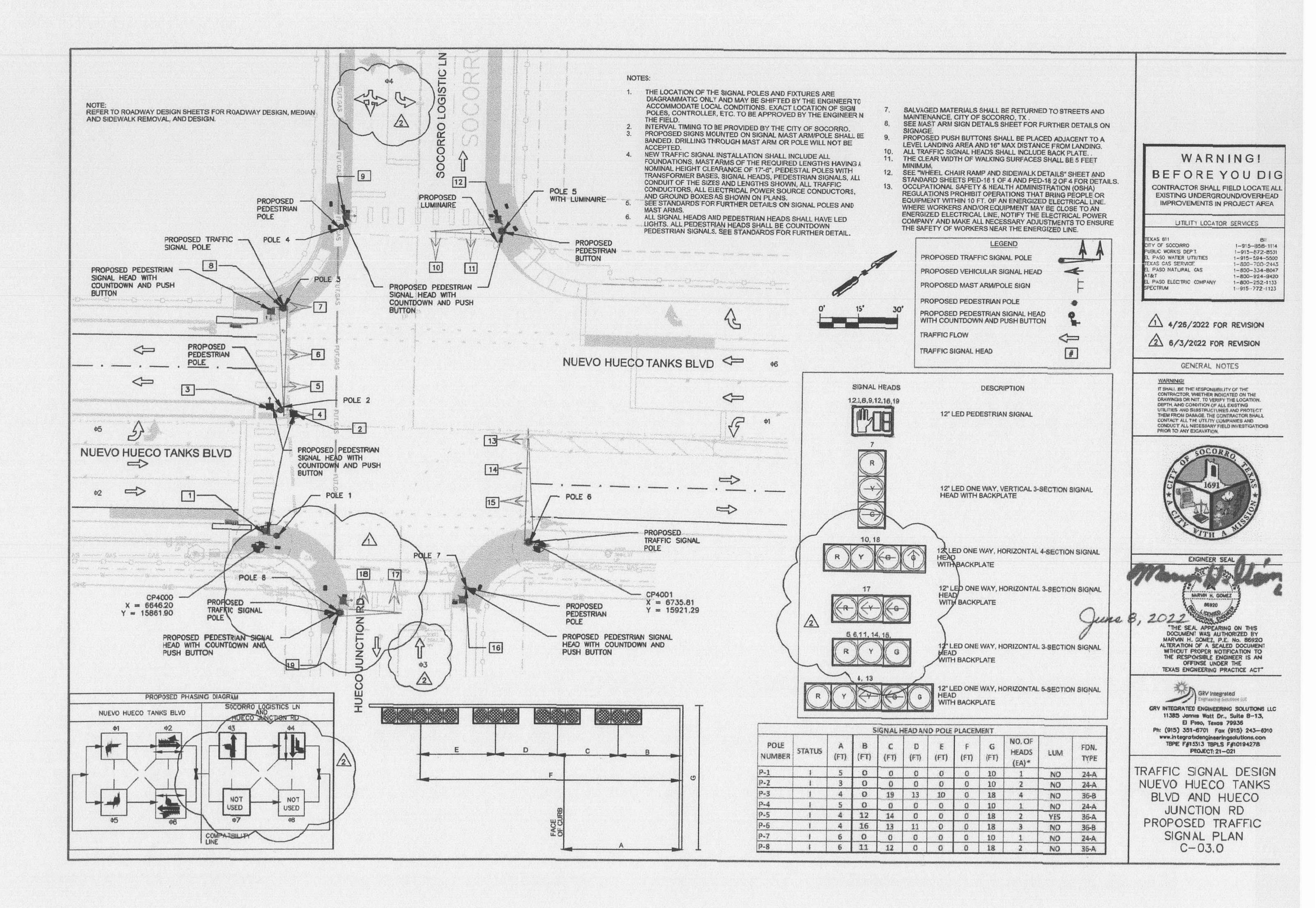

ATTACHMENT "B" Updated Program Policy

SMALL BUSINESS RECOVERY GRANT POLICY

SECTION I. PURPOSE

This policy aims to define this economic recovery assistance program and establish the standards for implementation either internally or in coordination through a third-party vendor. Socorro-based small businesses that exist or new small businesses may be considered to rebuild and grow their businesses. The City of Socorro (COS) will use the American Rescue Plan Act (ARPA), Coronavirus State, and Local Fiscal Recovery Funds (SLRF) funds to help cover the cost of this economic recovery pilot program. This program is based on additional available funding from the initial amount of \$250,000, of \$100,000 and is offered on a one-time basis to qualifying small businesses. COS is under no obligation to approve any requested assistance and the right to receive assistance through this program is neither intended nor implied. COS reserves the right to grant or deny recovery grants on a case-by-case basis by an authorized third party upon review and approval. COS reserves the right to adjust the policy requirements at any time.

SECTION II. DEFINITIONS

- Applicant The owner(s) of a business that submits a formal application requesting assistance under the City of Socorro's Small Business Economic Recovery Grant.
- Small Business A small business under this policy is a business that has 20 or few employees and is located within the city limits of Socorro.
- Third-party administrator A firm or agency that has a sub-recipient agreement with COS to manage the small business economic recovery grant. A third-party administrator is also known as the sub-recipient in a request for proposals solicitation.
- Subrecipient The selected sub-awardee in the administration of funds or services to be provided on behalf of COS.

SECTION III. ELIGIBILITY

This small business economic recovery grant program will assist small businesses that have less than 20 employees and are located and in operation within the city limits of the City of Socorro. Small businesses must use the funds for capital or operational expenses based on the use of funds.

EVALUATION CRITERIA & USE OF FUNDS

The Subrecipient will administer the program to fund small businesses ("applicant(s)") based on the evaluation criteria described below. The Subrecipient will consider projects that have addressed the severity of the negative economic impact of COVID-19. Applicants must coordinate with the Subrecipient to determine if their business is eligible to receive funds and if their project is eligible for program funding. The Subrecipient must ensure businesses are eligible and projects constitute allowable use funds. There are two tiers of funding that applicants may be funded through. Business eligibility criteria and funding allocations per business are described below.

FUNDING AVAILABLE

A total of \$90,000 is available for this program. Funding allocations will be determined by the Subrecipient's assessment of eligibility, need, and determination of how the project addresses the negative economic impacts of the COVID-19 pandemic, however, no applicant may receive more than \$10,000 in funding.

APPLICANT ELIGIBILITY

The applicant must have 20 or fewer employees and cannot have earned more than \$2 million in gross receipts in any of the past 3 fiscal years (if it was in business). The applicant's business location must be in Socorro, TX.

- Eligible Business Types:
 - Arts & Entertainment businesses (i.e., theater, arcade, music venues, etc.)
 - Construction-related business (i.e., cement, flooring, roofing, etc.) located in a properly zoned site
 - Restaurants and taverns (i.e., Bar & grill, cafes, food trucks)
 - Hotels (i.e., Bed & Breakfast Inn)
 - Home-based businesses that are looking to transition to a physical locality within the city limits of the City of Socorro
 - Medical (i.e., doctor's office & laboratory facility, veterinary)
 - Manufacturing business
 - Retail businesses, but does not include discount stores and used appliance stores
 - Veterinary Services
 - Warehousing located in a properly zoned site
- Businesses Not Eligible:
 - Adult businesses
 - Automotive sale, service, or storage
 - Junkyard facilities
 - Metal recycling facilities
 - Pawnshops
 - Payday loan and predatory lending businesses
 - Discount retailers / "dollar stores"
 - Used appliance resellers
 - o Multi-family "for sale" housing/mixed-use projects
 - A home-based business that is NOT looking to transition to a physical locality within the city limits of the City of Socorro
 - Used tire sale, service, or storage

APPLICANT TRAINING REQUIREMENTS

Applicant must register and complete specific business skills that address any of the areas mentioned below offered through various educational venues such as EPCC, UTEP, SBA, or a local non-profit agency that provides small or micro business workshops:

- Planning a Business (i.e., financial options, legal requirements, business accounting, business planning, etc.),
- Launching a Business (i.e., Marketing, sales, social media marketing, etc.)
- Managing a Business (i.e., employee recruitment, understanding the customer, etc.), or
- Growing your Business (employee training, export marketing, etc.),

Funded applicants <u>must complete a minimum of ten (10) hours</u> in a business workshop(s) or webinar(s).

Workshops must be provided online or face-to-face and must be a minimum of 2 hours in duration each. A certificate for each workshop must be provided to count towards the training requirement.

Workshops and training sessions provided as part of this program must be made available to the general public in addition to funded applicants, with funded applicants taking priority if and when space limitations arise.

SECTION IV. ECONOMIC RECOVERY GRANT PROCESS

COS may internally administer or source out the economic recovery assistance grants to a third-party administrator. Either way, the following documents will be required of all applicants.

- Application form with the following documents (a copy will suffice):
 - Articles of Incorporation, or Assumed Name Certificate to verify the existence of business in Texas
 - Warranty Deed or Lease agreement to verify ownership or lease of property
 - Business registration in the City of Socorro
 - If a new business, a bank statement showing it has opened a bank account in the name of the business (with a minimum balance of \$500) for the most current month, or a letter of credit from a financial institution.
 - Any other documentation that may be required for federal compliance.

ATTACHMENT "C" Subrecipient Scope of Work SMALL BUSINESS RECOVERY GRANT PROGRAM

Purpose

This fund is intended to support small businesses within the City of Socorro to address the negative economic impacts of the COVID-19 pandemic through the provision of technical assistance and forgivable loans or grants to small businesses in Socorro, Texas. The program was previously allocated \$250,000 and is now receiving an additional influx of \$100,000 (\$90,000 available for grants and \$10,000 for administrative costs). The maximum funding award through this second round of assistance is \$10,000. Small businesses must use funds for capital or operational expenses based on the use of funds.

Business Qualifications:

Funding assistance is available to businesses on a first come first served basis. All applications will be reviewed based on verified business information and per the Program's Policy (See Attachment B). Small businesses must explain the purpose in detail to ensure that it will be an allowable use of funds.

Small businesses and entrepreneurs must meet the following guidelines:

- Annual revenues of not more than \$2 million from all business activities. If a new business, funds of no less than \$500 must be in the business account or a letter from a financial institution that the applicant is in good standing;
- Limited to businesses located, and that will remain located, within the city limits of the City of Socorro;
- Demonstrate a negative impact due to the COVID-19 pandemic through:
 - o loss of revenue in years 2020 or 2021, or
 - Difficulty in finding qualified employee(s), or
 - Closure of business for a given time frame due to the COVID-19 pandemic or
 - Difficulty in finding market rate financing to start or expand business;
 - Or other documented negative impact due to the COVID-19 pandemic
- Eligible business types, as defined in the Program Policy include:
 - Arts & Entertainment businesses (i.e., theater, arcade, music venues, etc.)
 - Construction-related business (i.e., cement, flooring, roofing, etc.) located in a properly zoned site
 - Restaurants and taverns (i.e., Bar & grill, cafes, food trucks)
 - Hotels (i.e., Bed & Breakfast Inn)
 - Home-based businesses that are looking to transition to a physical locality within the city limits of the City of Socorro
 - Medical (i.e., doctor's office & laboratory facility, veterinary)
 - Manufacturing business
 - o Retail businesses, but do not include discount stores and used appliance stores
 - Veterinary Services
 - Warehousing located in a properly zoned site
- Businesses not eligible for funding are described in the Program Policy

Eligible Expenditures from Businesses

Businesses may apply for the following expenses associated with starting, re-starting, or expanding business operations: working capital, payroll for job retention or business expansion, rent/mortgage for business location, remodeling, or other general operating expenses.

- Applicants will have the ability to submit their application during the application period; •
- Applicants may request a phone or video conference •
- Applicants may apply or set up a meeting at the City of Socorro's E.G. Chayo Apodaca Community Center when an EPCCED staff is present;
- Applications must be completed with all verified documentation uploaded; •

Application Underwriting:

- EPCCED will review each application and respond to an applicant with an approval or denial no later than 15 days from completion of the application;
- If documents are missing, EPCCED will request all documents before making a decision, • however applicants funding is not guaranteed;
- Business owner will be notified in writing of approval or denial of grant. This can be in the • form of an email via DocuSign or a mailed document;
- Applicants must be notified in their grant agreement that a failure to use funds as intended in • their application request will subject them to immediate forfeiture of funds.

Closing & Funding:

- EPCCED will review each applicant's file upon closing for verification of all eligibility, training and project completion documentation;
- Grant recipients must maintain records on opening/remodeling or expansion completion, • receipts for expenditures of grant funds and staff payroll records;
- All grant recipients should receive a follow-up survey;
- Funding will occur within 5 days from City of Socorro advancement of funds, based on schedule in agreement.

SUBJECT: FISCAL YEAR 2024-2025 BUDGET

The Fiscal Year 2024-2025 Budget for the City of Socorro is hereby transmitted to the City Council for adoption prior to September 12, 2024.

For Fiscal Year 2024-2025, the City will continue its priorities of developing long term plans to address the needs for public safety, storm water drainage, and infrastructure improvements, along with maintaining the compensation of employees to competitive levels.

OVERVIEW

The Fiscal Year 2024-2025 Budget's primary focus is allocating resources towards, maintaining salaries commensurate with the inflationary trend, various capital projects to include storm drainage, as well as economic recovery and public health programs.

The Fiscal Year 2024-2025 budget outline has \$21,067,503 in public resources to be invested in the City of Socorro. The Fiscal Year (FY) 2024-2025 budget is approximately a 29.84 percent decrease from the FY 2023-2024 budget of \$30,028,611.

REVENUE

The City of Socorro utilizes the fund accounting method of financial reporting. The budget has four major funds: General Fund, Special Revenue, Capital Projects, and Debt Service. These funds were established to segregate specific revenue sources and activities in accordance with special regulations, restrictions, or limitations.

The following chart compares the estimated revenue for FY 2024-2025 by fund type for the three previous fiscal years. For FY 2024-2025, the General Fund will increase by \$1,641,934. The Special Revenue Fund will decrease by \$2,008,935; the Capital Projects Fund will decrease by \$8,600,000; the Debt Service Fund will increase by \$5,893.

GENERAL FUND

The General Fund is the primary operating fund of the City. All revenues that are not allocated by law or contractual agreement to a specific fund are accounted for in the General Fw1d. General Fund revenues include property taxes, sales tax, utility user taxes franchise fees, licenses and permits, current service charges, earnings on investments and other miscellaneous revenues.

The projected General Fund revenue of \$16,936,784 accounts for 80.39 percent of the 2024-2025 total of all budgets and can be allocated to any City expenditure category.

SPECIAL REVENUE FUND

The Special Revenue Fund is used to account for the proceeds from specific revenue sources that are legally restricted to expenditures for specific purposes. The Special Revenue Fund includes Federal, State, and local grant resources secured by the City to fund restricted activities. The \$1,784,662 in the Special Revenue Fund represents 8.47 percent of the 2024-2025 total of all budgets.

CAPITAL PROJECTS FUND

The Capital Projects Fund accounts for and reports financial resources that are restricted, committed or assigned to expenditure for capital outlays, including the acquisition or construction of capital facilities, other capital assets and repayment of loans from the General Fund for approved items by city council. Capital projects funds exclude those types of

capital-related outflows financed by proprietary funds or for assets that will be held in trust for individuals, private organizations, or other governments. No funds will be committed or assigned to expenditure for capital outlays for the 2024-2025 fiscal year.

DEBT SERVICE FUND

The Debt Service Fund is used to account for the accumulation of tax revenues for the payment of long-term debt. Debt Service Funds are generally used when funds are paid to satisfy debt obligations. The Debt Service Fund is projected at \$2,346,057 and reflects 11.13 percent of the 2024-2025 total of all budgets.

GENERAL FUND RESERVE

The General Fund started the 2023-2024 Fiscal Year with \$8,669,755 in reserves. That level of reserves represents 51.19 percent of the projected expenditures in the 2023-2024 General Fund Budget.

The 2023-2024 Budget was projected to use \$1,662,802 of the General Fund Reserve.

There will be an estimated amount of \$7,006,953 in the General Fund Reserve at the end of the 2023-2024 Fiscal Year.

The General Fund Reserve requires a 16.67 percent reserve balance of the total yearly budgeted expenditures or \$16,936,784. The projected required reserve is \$2,823,362.

THE BUDGET INCLUDES:

A Cost-of-Living Adjustment of 3.2% was incorporated into the budget for all filled positions as of the end of the current fiscal year. This effectively increased the budget by \$206,969. Notable increases in funds are as follows:

The City Manager's Department will include a salary adjustment for the Fleet Mechanic and Shop Technician roles. The adjustment amount is \$4,424 and will take place on the employee's anniversary date. The addition of a Custodial position will increase the budget by \$45,250, which includes fringe benefits. Service contracts for Sidewalk Phase II in the amount of \$600,000 have been budgeted.

The IT Department will include a salary adjustment specifically impacting the IT Director in the amount of \$370 and will take place on their anniversary date. There will be an addition of an IT Technician position in the amount of \$47,686, which includes fringe benefits. Also, the department will be purchasing the Police Department's first net router in the amount of \$30,000.

The Public Works Department will include a salary adjustment specifically impacting Equipment Operator and Laborer roles in the amount of \$5,571. The adjustment will take place on the employees' anniversary date. Also, the budget includes the purchase of an 18-Wheeler Cab in the amount of \$50,000 and a truck in the amount of \$50,000.

The Police Department will have a salary adjustment increase of \$316,039, specifically impacting Police Officers, Detectives, Sergeants, Lieutenants, and Communication Dispatcher roles. The adjustments will take place at the time of the employees' anniversary date.

The Municipal Court includes ADCOMP system to receive online payments in the amount of \$3,600, the installation of waterproof windows in the amount of \$8,000 and an increase of \$20,000 to the Judge's contract.

The Planning and Zoning department includes a salary adjustment specifically impacting the Director role in the amount of \$1,798. The adjustment will take place on the employees' anniversary date. Also, the department will be adding a Planner position in the amount of \$80,314, including fringe benefits.

The Grants department will include a salary adjustment specifically impacting the Director role in the amount of \$2,821 taking place on their anniversary date. The Program Officer Compliance job description has been amended to Grants Compliance Officer and includes a salary adjustment of \$2,080. Also, the department will be creating an in-house position for the Economic Recovery Coordinator with a budgeted salary of \$65,149. ARPA will cover a portion of the salary in the amount of \$16,417, through December of 2024. The department plans to purchase a Start Up Business Hub/ Shop Local Directory in the amount of \$7,500.

The City Clerk department includes a \$90,000 election cost.

The Finance department will include a salary adjustment specifically impacting the Director role in the amount of \$9,913. Also, the department will be adding a Finance Technician position in the amount of \$52,158, including fringe benefits. The Service Contracts include an increase of \$70,000 for additional services to be rendered by a CPA Firm.

The Recreations department includes an increase of Service Contracts in the amount of \$20,000 for additional services, and an increase in the following resulting from the city seeking designation as a National Historic Landmark: Support Activities in the amount of \$9,000, Events in the amount of \$20,000, and Seminars and Trainings/ Travel Mileage in the amount of \$5,000.

The Ambulance includes an increase in Building and Property Maintenance in the amount of \$1,000 and an increase in utilities to the amount of \$5,000 since the department is now using the Poona station as well.

The grand total of increases included in the 2024-2025 budget is \$1,692,392.

RECOMMENDATION

The City Manager hereby submits the Fiscal Year 2024-2025 Annual Budget to the City Council for adoption subject to revisions, if any, by City Council, reflected in the meeting's minutes.

The Receptionist responds to public contact with citizens by providing the appropriate information and/or directing them to the proper department. This position involves a high level of visibility, as it is the public's initial contact, both via the phone and in person, with the City. Work also involves the performance of clerical support functions to administrative staff on a daily basis.

The District operates under Texas Health and Safety Code, Chapter 772. It is governed by a Board of Managers appointed by the entities it serves. By statute the Board is made up of one member from the County of El Paso, two members from the most populous city in the County (City of El Paso), one member from the second most populous city in the County (City of Socorro), one member appointed, at large, by the Board of Managers to represent all other entities within the County, and one member from the predominant phone service provider (AT&T).

District Funding

The District is funded by 9-1-1 service fees. Fees are collected monthly from both wireline and wireless phones and remitted to the District. The Board maintains local control of wireline fees and sets the rate each year as a part of the budget process. For FY2025 the Board has maintained the fee from FY2015 of \$1.38 per residential line and \$4.46 per business line.

Wireless fees are set by the State of Texas. For FY2024 the wireless fee is \$.50 per line or 2% of any pre-paid phone service. The fees are collected by the State Comptrollers and distributed to 9-1-1 entities based on population.

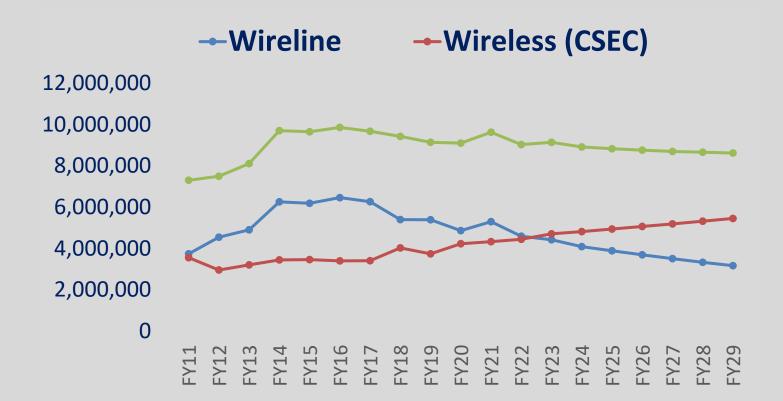

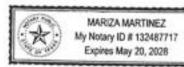

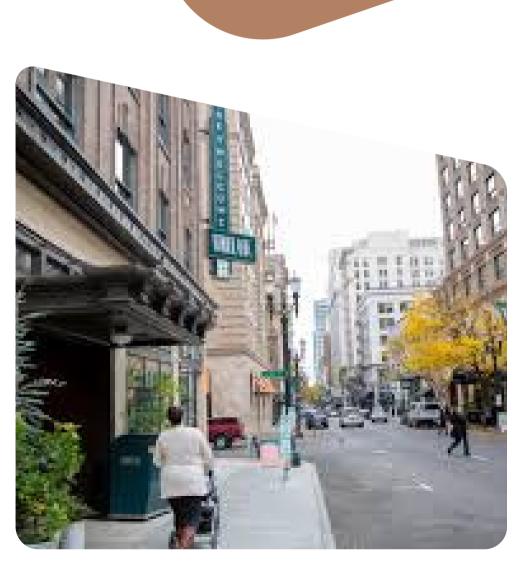
