On August 12, 2024, the El Paso County Commissioners Court unanimously approved calling an election for five propositions on the November 5, 2024 General Election Ballot. The Capital Improvement Bond would fund approximatley \$323.8M in projects to be implemented countywide over the next several years. Voters will have the opportunity to vote on each proposition separately. The propositions are as follows:



PROPOSITION A: PARKS AND RECREATION

The County proposes **\$95,615,000** for the public purpose of constructing, rehabilitating, renovating, improving, upgrading, updating, expanding, enlarging, and equipping the County's parks and recreational spaces and the acquisition of land, easements, rights-of-way, and other real property interests necessary.



PROPOSITION B: OFFICE OF THE MEDICAL EXAMINAR

The County proposes **\$26,700,000** for the public purpose of constructing, rehabilitating, renovating, improving, upgrading, updating, expanding, enlarging, and equipping facilities for the County's Office of the Medical Examiner and the acquisition of land, easements, rights-of-way, and other real property interests necessary.



PROPOSITION C: COURTHOUSE, SUB COURTHOUSES AND RELATED ANNEXES

The County proposes \$63,285,000 for the public purpose of constructing, rehabilitating, renovating, improving, upgrading, updating, expanding, enlarging, and equipping the County's courthouse, sub courthouses, and related annexes and the acquisition of land, easements, rights-of-way, and other real property interests necessary.



PROPOSITION D: COUNTY COLISEUM RENOVATION

The County proposes **\$105,485,000** for the public purpose of constructing, rehabilitating, renovating, improving, upgrading, updating, expanding, enlarging, and equipping the El Paso County Coliseum and adjacent facilities and the acquisition of land, easements, rights-of-way, and other real property interests necessary.



PROPOSITION D: COUNTY ANIMAL SHELTER

The County proposes \$32,710,000 for the public purpose of constructing, rehabilitating, renovating, improving, upgrading, updating, expanding, enlarging, and equipping the County's Animal Shelter and the acquisition of land, easements, rights-of-way, and other real property interests necessary.


IMPACT ON HOMEOWNERS

The County's debt service tax rate is currently approximately \$0.05 per each \$100 of property valuation. Based on current property tax value assumptions, if the Capital Improvement Bond is approved, the County's debt tax rate will increase by an estimated \$0.03, which would increase taxes by about \$5 per month based on the average home value price of \$200,956 in 2024.

NO NEW REVENUE TAX RATE APPROVED

As a matter of information, on August 26, 2024, the El Paso County Commissioners Court voted to support the No New Revenue Tax Rate for the FY25 budget year. At \$0.426323, this rate is more than 3 cents lower than the County's tax rate in FY24. This is the 3rd time in the past 4 years the County has adopted a reduced tax rate.

BACKGROUND

The County held 24 public meetings beginning in February 2024 to gather community input on project priorities. The Commissioners Court then tasked the Bond Advisory Committee (BoAC), a citizen-led group of volunteers, to develop a recommended project list and financing structure.

The Court finalized this process at their August 12, 2024 meeting by voting unanimously in favor of calling an election for five propositions that are to be included on the November 5, 2024 General Election ballot.
