IMPORTANT: The City of Socorro Color Run is a 3K Fun Walk/Run. This is not for competition. The race is designed to have numerous stations splashing/throwing powder paint at the participants. This paint is a flour, corn starch, baking soda & F.D. & C dyes and is non-toxic; also free of any heavy metals. It can stain clothing, but most will wash out. As with anything dirty, we suggest washing garments sooner than later. Animals are not allowed to participate in the race. To avoid getting color on car seats we advise to bring towels for the ride home. The paint should not interfere with vision or breathing however we advise anyone with a breathing condition, or are pregnant consult their doctor before participating. To protect eyes we advise wearing sunglasses or a bandana around their mouth. The race is not timed, and there is a color explosion celebration held at the end of the race free to anyone who would like to participate. Please read the entire document before signing as it has a significant effect on your legal rights. This document is
intended to protect the City of Socorro and its employees from all liability related to participation in the City programs.
Unconditional Release and Waiver: I, on behalf of myself, my spouse, my parents and my children, agree that in the event I or my child/ward sustains personal injury or property damage as a result of participation in the program offered through the City of Socorro Recreation Department, that the City of Socorro and its agents and employees (collectively, "Releasees") will not be liable for such injury or damage, and I hereby release, acquit and discharge Releasees of and from any and all claims and causes of action for such injury or damage and further agree to indemnify and hold harmless Releasees or same, including for such injury or damage that is caused Releasee's negligence. I understand that by waiving rights against the City of Socorro, I am giving up the right to seek all legal remedies against the City of Socorro which might otherwise be available to me, my spouse, my parents and my children, including, but not limited to, economic damages, consequential damages, and attorney's fees. Assumption of the Risk: I understand that it is my responsibility to inquire about the parameters of a program's
activities and to assess the ability of my child/ward and myself to safely participate in the program. I further understand that certain activities are potentially dangerous, and I assume on behalf of myself and my child/ward all risks associated with participation in any program.
Effect: I understand that this Waiver and Release form is binding as to my family members, heirs and executors. In case of a medical emergency, accident or illness, the City of Socorro has my permission to secure medical attention as with the program information, and I agree to abide by the terms and requirements described therein, I further agree that if I do not understand any portion of the material, I will ask for further clarification.
Medical Release: I (Parent/Guardian) do hereby authorize the City of Socorro Recreation Department to provide emergency medical treatment to my child/myself, in the event of an emergency and I am unreachable. I further authorize treatment to be provided by a licensed medical practitioner or facility determined by the staff to be best able to serve my child's needs, and further, I understand that I am responsible for any expense associated with such treatment. I understand that every effort will be made to contact me or the person designated by me as soon as possible after such an occurrence.
Release for Media and Promotional Photographs/Interviews: I give permission for myself/son/daughter to be photographed or interviewed by the local media during the event and also for the City of Socorro to take promotional pictures of myself/child during the event and use them for commercial purposes.

The City of Socorro Recreation Department Participants Code of Conduct

Each participant is expected to do the following:

- Demonstrate courtesy even when others do not.
- Behave in a responsible manner, always exercising self-discipline.
- Respect the rights and privileges of the other participants and City staff.
- Respect the property of others, including City property and facilities.
- Cooperates with or assists the City staff in maintaining safety, order and discipline.

Unacceptable behaviors include the following:

- Being involved in an isolated instance of any form of insubordination.
- Failure to conform to all city rules.
- Directing profanity, vulgar language or obscene gestures.
- Defacing/damaging city property or the property of others.
- Engaging in inappropriate physical or verbal contact and/or gang activity.
- Running, pushing, shoving, littering, throwing objects (which is not part of a supervised activity).
- Producing loud, rude or unnecessary noises.
- Incidents involving drugs, alcohol, weapon, etc.

Repeated violations of any of the stated will be grounds for the following discipline options:

- 1. Dismissal/Ejection of Event
- 2. Conference Between Individual/Child & Parents with City Staff and/or Police
- 3. If any crime has been committed or act against a City Ordinance by any individual can and may lead up to adverse action deemed fit by City of Socorro Staff.
- 4. Restitution
- 5. Banning Form Further Participation in City Events

Any participant brining in personal items are responsible for them. The City of Socorro provides no lockers or holding area for items.

No Campaigning of any kind will be allowed at City of Socorro sponsored events/functions/activities or inside City Buildings or on City Property.
