- * City Staff may video tape/photograph the property for commission review & place a notice sign on the property.
- * Approval by the commission does not take the place of a building permit. Permits must be obtained from the City of Socorro Planning & Zoning Department 860 N. Rio Vista Rd. Socorro, TX 79927. (915) 872-8531
- * All City Permits/ Certificate of Appropriateness must be displayed on the jobsite.
- * Staff may require additional information if it is deemed necessary to complete the application.
- * The applicant affected by any denial of the HLC regarding a Certificate of Appropriateness may appeal the decision to the City Council for final determination. All requests shall be filed in writing to the HPO within 10 days of the HLC's decision.
- * If the Certificate of Appropriateness is approved, a building permit must be obtained within 1 (one) year from the date of approval, otherwise, the Certificate of Appropriateness is null and void and must be reconsidered.
- * Submission/Approval of Certificate of Appropriateness, does not constitute approval of a building permit. Building permits shall be submitted separately. This form must be presented at the time of a request for a building permit.
- * If the property owner does not appear personally before the commission, a letter or signature of authorization must be presented to the Historic Preservation Officer or the case will not be heard

* I certify that the information contained in this application for a COA is correct and complete to the best of my knowledge, and that I am now or will be fully prepared to present the application to the HLC at its public hearing. I authorize members of the HLC and employees of the City to visit and inspect the property that is the subject of this application. CERTIFICATION * I understand that any property owner dissatisfied with the decision of the HLC regarding the issuance or denial of a COA shall have the right to appeal that decision to the appropriate Board of Adjustment within 10 calendar days after receipt of notification of such action. The appeal must be in writing and filed with the HPO and the HLC Secretary and must specify the grounds for such appeal
